Detailed notification for Web Based Counseling

**DETAILED NOTIFICATION FOR SPECIAL ROUND OF WEB COUNSELLING**

The GATE / GPAT qualified and eligible candidates of 2019, 2020 and 2021, and TS PGECET qualified and eligible candidates of 2021 are informed to attend special round online TS PGEC / TS PGECET Web Based Counseling for admission to M.E./ M.Tech./ M.Arch / M.Pharmacy / Pharm.D (P.B.) courses for the academic year 2021-2022 as per the schedule given below.

**a. Schedule for – TS PGEC / TS PGECET-2021 ADMISSIONS**

- ✚ **Candidates who have already attended for Certificate Verification in First Phase and second phase can directly exercise web options for special round of Counseling as per the schedule.**
- ✚ Candidates are informed that they should satisfy the admission rules prescribed in the related G.O. MS. No.153 besides satisfying the eligibility criteria of the respective universities and should be prepared to pay the tuition fee as applicable.
- ✚ The leftover seats after allotment for GATE / GPAT candidates are available for TS PGECET candidates
- ✚ This notification itself is a call for web counseling. No separate call letters are sent to the individual candidates.
- ✚ Mere attending of the web counseling does not guarantee a seat.
- ✚ Candidates who have not yet registered and uploaded the certificates are informed to register online at <http://pgcetadm.tsche.ac.in> from **06<sup>th</sup> January, 2022 and 07<sup>th</sup> January, 2022** and furnish all information in the online application form. All the entries should be correct and the candidate is

responsible for any incorrect entry. All the candidates have to pay non-refundable Processing Fee Rs. 1,200.00 (Rupees: One thousand two hundred only) and Rs. 600.00 (Rupees: Six hundred only) in case of (SC/ST Candidates) towards Registration cum Verification process which has to be paid through online payment (Credit Cards/Debit Cards/Internet Banking) in favour of 'Secretary, TSCHE'.

✚ **Who should participate in special round?**

- I. Who secured a seat in phase I and in phase II of web-based counselling and wish to move to some other college.
- II. Candidates who participated in phase I and in phase II of web-based counselling and could not secure a seat.
- III. Candidates who did not participate in phase I and in phase II even though he / she has been called for counselling.
- IV. Candidates who were allotted a seat but didn't report.
- V. A candidate allotted a seat in phase I and in phase II but cancelled his / her admission.

✚ **The candidates may note that,**

- I. Options exercised in phase I and in phase II will not be considered for special round counselling.
- II. Candidates have to exercise options afresh for each phase of web-based counselling.
- III. In case, if they are satisfied with the previous allotment, options need not be exercised again.
- IV. Options may be exercised for those colleges even if the vacancies are not available, as vacancies may arise due to sliding, cancellation and conversions.

✚ If the candidate secures a seat in special round, he / she will lose the claim on the earlier allotted college, and has to report to the new college by joining letter, Challan form for payment of tuition fee (if applicable). Fee has to be paid at any branch of Union Bank / Andhra Bank in the State of Telangana. After payment of tuition fee (if applicable) the students have to **report to the allotted college** with original certificates for physical verification, fee paid challan and joining letter. Failing to report within the date furnished in the allotted college, the candidate will forfeit the claim on the new college as well as in the old college.

**b. Eligibility:**

1. The candidate should be of Indian Nationality.
2. The candidate should belong to the State of Telangana / Andhra Pradesh.
3. The candidate should satisfy the local/non-local status requirements as laid down in the regulations of admission. (Ref. G.OMs.No.153 dated 22-08-2007)
4. Candidate should obtain at least 50% marks (45% in case of candidate belonging to reserved category) in the qualifying examination.

**c. Certificates to be uploaded at the time of Registration and filling application form**

The GATE / GPAT / TS PGECET qualified, eligible candidates have to scan and upload all original certificates for verification.

The candidates shall upload copies of the following Original Certificates for verification.

- i. GATE Score / GPAT /PGECET Rank Card
- ii. SSC Pass Memo or its Equivalent for proof of Date of Birth.
- iii. Provisional Certificate
- iv. Transfer Certificate.
- v. Consolidated marks memo or memorandum of marks semester wise
- vi. Study certificates from 10<sup>th</sup> class to Graduation
- vii. Residence certificate for preceding 7 years of the qualifying examination i.e. Graduation in respect of candidates who have private study without any institutionalized education.
- viii. Integrated community certificate (Caste Certificate) issued by the competent authority in case of BC/SC/ST candidates, if applicable
- ix. Economically Weaker Sections (EWS) Reservation (applicable only to OC candidates): \*As per the Guidelines issued in G.O.Ms.No.244, General Administration (SER.D) Department, Government of Telangana, dated. 24.08.2021, the 10% Reservation to the Economically Weaker Sections (EWS) in respect of Admissions into Educational Institutions shall be implemented. Candidates should produce EWS Certificate issued by MRO/ Tahsildar valid for the year 2021-22 (i.e issued after 01.01.2021).
- x. Residence certificate from M. R. O of either of parents in Telangana for 10 years in case of non-local candidates.
- xi. In respect of Non-Local candidates in order to consider them for allotment under unreserved seats the following certificates needs to be submitted.  
**Residence Certificate:** Candidates who has resided in the State for a total period of 10 years excluding periods of study outside the State; or either of whose parents have resided in the State for a total period of 10 years excluding periods of employment outside the State.  
(OR)  
**Employer Certificate:** Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporations, Local bodies, Universities and other similar Quasi Public Institutions within the State at the time of applying for GATE/GPAT/TS PGECET- 2021) examination
- xii. The Muslim and Christian Minority Candidates should upload the “TC” of the SSC containing Minority status (or) in the absence of TC, a Certificate issued by the Head of the Institution in which the student studied/appeared for SSC or its equivalent examination.
- xiii. Latest Parental Income Certificate issued by M.R.O., Telangana Govt. after 01.01.2021.

**Note:** \* Any false or incorrect information furnished detected at any stage will render the admission of the candidate null and void.

\* The Convener reserves the right to cancel the admission of the candidates at any stage if/ when it is detected that admission is against the rules.

**d. Certificate verification and counseling:**

1. The preliminary certificate verification will be done based on scanned copies of original documents uploaded and as per norms.
2. In case of any doubt, enquiry will be done over phone to establish the veracity and correctness of documents.
3. Procedure for exercising options will be made available on the website i.e. <http://pgcetadm.tsche.ac>. in well before the commencement of the option entry.
4. List of Provisionally selected candidates will be prepared College wise and will be placed in the website i.e. <http://pgcetadm.tsche.ac>.

5. The candidate has to download the fee payment challan and the joining report.
6. Tuition fee has to be paid by challan at the designated banks.
7. Final allotment of seat for admission is subject to satisfactory verification of all **original certificates at reported college** and producing **fee paid challan**.
8. Candidates have to report to the concerned college and produce all original certificates within the stipulated time.
9. Allotment order will be issued at the allotted college by the principal / verification officer after verification of the original certificates. The candidate has to submit at the college the joining report along with fee paid challan and original T.C.
10. Candidates have to submit two sets of attested copies of all certificates at the respective colleges, one set is meant for submission to the office of the Convener.
11. If the candidate cancels his/her admission, tuition fee will be forfeited as mentioned below:
  - After first phase, full tuition fee will be refunded.
  - 50% of the amount after final phase and before cutoff date notified for cancellation in allotment order and 100% thereafter.

**e. Rules of Reservation for admission.**

Admissions will be made as per rules of reservations in vogue at the time of Counseling.

1. Cent-percent (100%) of seats in University College and 70% of the sanctioned intake of seats in unaided (affiliated), non-minority and minority professional institutions will be filled by the Convener TS PGECET-2021 Admissions.
2. In the affiliated Colleges of Telangana State, admission to 85% of the convener quota of seats shall be reserved for the local candidates of Telangana State and the remaining 15% shall be Un-reserved seats.
3. The candidate shall satisfy Local / Non local status as per GO.No.646 Edn. (W1) department dated 10-07-1979 and Presidential order. The Non local candidates are eligible for 15% unreserved seats only. The local candidates are also eligible for 15% unreserved seats along with 85% seats reserved for local area.
4. The seats in School of Planning and Architecture (SPA), JNAFAU which is a Statewide Institution shall be filled as per the Presidential order. In other words, admission into 85% of seats shall be reserved for the candidates belonging to three local areas AU, OU, SVU in the ratio 42:36:22 and the remaining 15 % seats shall be Unreserved.
5. The Principals are directed to fill up the management quota of seats in their respective colleges by issuing a separate notification in the leading daily Newspapers and following TSCHE guidelines. Candidates should be admitted as per admission rules in vogue. The details of the seats filled under “Management Quota” shall be communicated to the “Telangana State Council of Higher Education (TSCHE)” for necessary approval and ratification.
